We have now considered your request of 14 July 2016 for the following information:

Please can you provide your total spend against the NUWPEC agreement for the Supply of Electronic Components and Associated Products, Service Kits, Tools, Fixings, Test & Measurement Equipment and Batteries for the last financial year. Where possible please provide the suppliers you bought from. Where possible please supply the products you bought and the price of each.

Our response is on page 3 of this letter, accompanied by a copy of your request, and within the document entitled FOI_16-145_Appendix A.xlsx attached to this letter.

We note that as your request indicated we should only provide the names of suppliers, the items purchased and the price of each "...where possible...". We have concluded that some of this information, particularly related to the price of individual items, is statutorily barred from release by one or more exemptions within the Freedom of Information Act (FOIA) and therefore it is not possible to provide this information. We would thus consider this information outside the scope of your request and have so indicated within the appendix.

We hope this response will meet your requirements, however if you are not satisfied you have the right of appeal. If you wish to appeal, please set out in writing your reasons for appealing and send to the above address. You must appeal within 60 calendar days of the date of this letter. Any appeal received after that date will not be considered nor acknowledged. This policy has been reviewed and approved by the Information Commissioner's Office.
